

**GENERAL IMPOSITION OF RATES AND FEE-FIXING RESOLUTION FOR 2024
SEKONDI-TAKORADI METROPOLITAN ASSEMBLY**

LOCAL GOVERNANCE ACT 2016, ACT 936 (PART V SEC.137-169)

It is hereby resolved and approved by the Sekondi-Takoradi Metropolitan Assembly in accordance to PART FIVE, Section 137 to 169 of the Local Governance Act, 2016 (ACT 936), that the following Rates, Fees, Licenses, Permit, Rent, and others be charged by the Sekondi-Takoradi Metropolitan Assembly for the Financial Year 1st January to 31st December, 2024.

It shall be the duty of every person liable to pay these Rates and Fees or part thereof to do so in the case of Annual Fees on or before 31st March, 2024.

Payment in all cases should be made at any Revenue Office of the Sekondi-Takoradi Metropolitan Assembly, Sub - Metropolitan District Council Offices or to the respective Revenue Collector or any authorised Rate Collector or through prescribed electronic platforms.

RATES EXEMPTIONS

The Local Governance Act, 2016 (Act 936) of Ghana exempt specific rate payers from paying specific fees and rates.

Rate Payers doing business within the Sekondi Takoradi Metropolitan Assembly are to note that for the purpose of Data Management, Exemption Impact Analysis and Development decision making, these exemptions as prescribed in the Local Governance Act, 2016 (Act 936) shall not be automatic.

Any Rate Payer doing business within the Sekondi Takoradi Metropolitan Assembly who qualifies or wishes to be exempted from paying any rate(s) / fee(s) in this Fee Fixing Resolution as provided in Act 936, shall apply for such exemptions in writing to the Metropolitan Assembly, stating reasons and attaching relevant documents.

Upon consideration and approval by the STMA Rates Assessment Committee, a Rate Exemption Letter shall be issued to the Rate Payer and copies to the Sub Metropolitan District Councils, Departments and Revenue Offices.

Due to changing development interests and time, the rate Exemption Letter shall be renewed periodically. The renewal process will allow STMA to satisfy herself that the Rate Payer still qualifies under law to be exempted.

REGISTRATION OF BUSINESS

Any Rate Payer wishing to do business within the Sekondi Takoradi Metropolitan Area, is required to register their Trade, Business, Social group, Association, etc.

Rate Payers not registered with the Sekondi Takoradi Metropolitan Assembly shall pay 30% in addition to all rates and fees charged them by the Assembly.

Rate Payers shall complete a Registration Form and submit. Upon approval by the STMA Rates Assessment Committee, a Registration Certificate and a Letter shall be issued. Also, registration details shall be added to the published list of businesses in good standing with the Assembly. STMA Rate Payer Registration shall cost a flat fee of GHc 300.00.

IMPOSITION OF RATES FOR PROPERTY OWNERS - RATES REVENUE ITEMS - PROPERTY

Under Sections 146 (3), (4), and (5)

A basic rate of GHc 1.00 per year is payable by all persons, male or female, of or above age of 18 years and up to 70 years who resides within the area of authority of the Sekondi-Takoradi Metropolitan Authority.

Under Sections 146 (6) and (7)

In addition to the basic rate, the following rates on Assessed and Unassessed rateable value of premises situated within the Metropolis, as set out within the schedule below, shall be payable by owners of such premises.
